To incorporate the city of Parker.

SECTION 1. Be it enacted, if •e., That the inhabitants of the Incorporation. towns of Lawrenceburg and Parker's Landing, in the county of Armstrong, residing -within the limits of the borough of Lawrenceburg and the boundaries hereinafter described; are hereby constituted a corporation and body politic by the name, style and title of the city of Parker, and by that Title. name shall be capable in law to purchase, receive and hold Powers and priviforever, or for any shorter time, lands, tonements_and here- lege& ditaments, goods and chattels, and by such narn6to sell and convey, mortgage, encumber and dispose of at their pleasure, and by the said name shall be capable in law to sue and be sued in all courts of record and elsewhere, in all manner of snits, actions, causes and complaints, that to the said city as a body politic and corporation in law and in fact shall and may appertain, and for that purpose shall have and use a common seal, and the same, from time to time, may change, deface and make anew : Provided, That all land lying within Land within cotthe following boundary, to wit : Beginning at the mouth of tain boundaries Bear creek, at the Allegheny river, thence in a westerly direction up said creek to the point where the line dividing Armstrong and Butler counties crosses the same ; thence north one and one-fourth degrees east, along said line, five hundred and seventy-six rods to a post; thence east to a point opposite the Western boundary line of the Allegheny and Clarion Oil Company's land; thence south along said land to the south-western corner thereof; thence east along said land to the Allegheny river ; thence down said river to the place of beginning, be and the same is hereby incorporated into said city and made part of the same.

SEeriox 2. That the said city shall be divided into wards Divided into two in manner following : All the territory lying north of the wards. northern l)ouhdary of Lawrenceburg borough shall constitute the Fir:A wz.rd; and all the remaining territory, including Lawrenceburg borough, shall constitute the Second ward.

SECTION 3. That the executive and legislative powers of Mayor and council_ said city shall be vested in a mayor and city council, which shall consist of four members from each ward; the present butess and :nen:hers or the town council of the borough of LaNvrencCelrg sl::.t11 continue in office as mayor and as members of city council of the ward. in which they reside, until the ent.⁷. of Li.eir respective terms, and shall discharge the duties inposed on them by this act, and their successors and all the officers provided for in this act shall be elected at the thee and in the same manner as the said burgess and town council have heretofore been elected; the mayor of said city shall hold his office for two years, and

 $\frac{Ordinances and}{10_g ob. sono to bo}$ tions shall be published in at least ,one newspaper printed in said city, or by at least twenty handbills posted in conspicuous places therein, and copies of the said laws, ordinances and regulations, certified under the seal of the said city, shall be filed with the recorder of deeds of the county of Armstrong, together with the oath of some credible person that the same have been duly published, and the said recorder shall record the same in a book to be kept for that purpose, and shall be entitled to the same compensation therefor as in the case of recording deeds ; and no law, ordinance or regulation of the said corporation shall have any force or effect until after the publication and filing thereof for record as aforesaid.

SECTION 8. That all powers, duties, authorities and priviaud privileges to loges now by law vested in and belonging to the burgess and belong to mayor town council of the borough of Lawrenceburg, in the county of Armstrong, shall continue and belong to the mayor and city council of the city of Parker.

> SECTION 9. That each ward shall be entitled to elect two justices of the peace; the two justices now acting within the city limits shall continue to be the justices of the respective wards in which they reside, and act until the expiration of their present term of office.

> SECTION 10. That the said city shall constitute one district for school purposes, and that the school directors shall be

elected by the qualified voters of said city, as provided by school directors. law for the election of school directors; three of said directors shall reside. in each ward.

SECTION 11. That each ward shall be entitled to elect one constables, ast constable, one assessor and one auditor, and all officers now sons and auditors. in office shall continue in office during their present term. All Vacancies. vacancies existing in offices hereby created, shall be filled at the first election held under this act.

SECTION 12. That said city shall constitute one district for Ono poor district. poor purposes, and shall be entitled to elect two overseers of Overseer. of poor... the poor, one for one year and one for two years; the one for one year shall reside' in the First ward, and the one for two years in the Second ward.
